# Regular Meeting

## Minutes

Village President Jane DeStaercke called the regular meeting to order in open session at 7:00 p.m. Board members present were Jane DeStaercke, Mike Kinas, Greg Steinbach, and Cheryl Rosemeyer in person and Eileen Grunseth and Ericka Bertsinger virtually. Village Public Works Director Rick Johnson, Chief of Police Thomas Tallier, and Village Clerk Candice Grunseth were present. Star News Reporter Ginna Young was present.

Police Chief Tom Tallier led the Pledge of Allegiance.

There was no Special Order of Business or Immediate Public Concerns.

Trustee Greg Steinbach made a motion to approve the following minutes and Trustee Mike Kinas seconded the motion: Regular Board Meeting November 11, 2020 and Finance Committee on December 7, 2020; All were in favor.

A motion by Trustee Eileen Grunseth and seconded by Trustee Mike Kinas to approve the vouchers/bills as presented. POOLED CASH for SSCU 32286-32292 and FORWARD 11968-12040, Restricted None, Journal Entries 0440-0442 and a Transfer for Tax Rebate, No CDBG Checks. Also WRS/WDC/TASC/EFTPS/DOR. The motion carried on a roll call vote of 6-0.

## Reports:

President Jane DeStaercke reported on contacting four law offices.

Treasurer's Report – Fran Prasnicki had a written report that was in the packet for the fund balances for November 12, 2020 to December 9, 2020 for the pooled cash accounts and other accounts. Trustee Eileen Grunseth made a motion to approve the Treasurer's report and Trustee Mike Kinas seconded the motion. All were in favor.

Chief of Police Tom Tallier had a written report for the Board.

Public Works Director Rick Johnson reported the water sewer reports were completed. The Sanitary survey report from last summer inspection was received.

Clerk's Report – A copy of the Clerk's report was in the Board packet. She noted that the Village would be receiving their Routes to Recovery fund tomorrow December 10, 2020. Village Clerk reported that all items were completed on the CDBG Library Expansion project. The Village is waiting on the final reimbursement from the CDBG grant of approximately \$44,000.

The December 9, 2020 budget was is in the Board packet for review and the Finance Committee reviewed the report at their meeting. Village Clerk Candice Grunseth noted that the budget included the sale of the Mobile Home Courts and Covid expenses.

Police Chief Tom Tallier stated that he would recommend Michael Shiffler due to the Village could utilize the paralegal when just needed a questioned answered and that would save the Village on costs. Village President Jane DeStaercke stated she was reappointing School Rep Debra Gallet and Village Rep Candice Grunseth to the Western Taylor County Public Library for another term.

Village President Jane DeStaercke noted that the Caucus would be January 13, 2021 and the same time as last year at 6:45PM.
