### SIDEWALK CLEANING REMINDER FOR WINTER 2014-2015

This is a reminder that if you have a sidewalk in front of your house, business, or unoccupied lot, you are obligated to clean the sidewalk. You shall keep all sidewalks in good sufficient safe repair and free of any snow, ice, dirt, or rubbish to the full width and extent of the sidewalk. If you fail to clean the sidewalk, the Village will clean the sidewalk at the homeowner's or the businesses expense.

#### **GARBAGE AND RECYCLING**

The Village of Gilman is changing to Express Disposal on January 1, 2015. The Village will still be paying for the recycling cost for residents and each residence will get a bin for recycling. You can purchase bags or order garbage cart from them and please call them directly. You can get bags at the Village office or at the Gilman Cornerstore for the cost of \$2.25 per bag. Pick up will still be Tuesdays but they stated that you have to have your garbage and recycling out by 6a.m. Advanced Disposal will pick up their garbage carts and their recycle bins on December 30<sup>th</sup> and 31<sup>st</sup> after their last pick up.

Remember, if you have a dog, you MUST have a license for that animal by January 31, 2015. **If you do not license your dog you could be referred to the District Attorney for prosecution**. # SEWER/WATER DISCONNECTIONS AND RECONNECTIONS CHARGES

The Village Board would like to remind all Utility Customers that there is a \$30.00 reconnection charge during business hours for turning your water back on when it is shut off and a \$40.00 reconnection charge if after normal business hours. This is in our Public Service Commission Rate File and will be enforced.

#### **SEWER**

Please DO NOT flush paper towels, gloves, napkins, tampons, diapers, pads, etc into the sewer system as this causes the system to back up and may back up into your own basement and cause damage to the system. Sewer Use Ordinance ~ **SECTION 5.** 

<u>PROTECTION FROM DAMAGE</u> ~No person shall maliciously, willfully, or negligently break, damage, destroy, uncover, deface, or tamper with any structure, appurtenance, or equipment which is a part of the wastewater collection and treatment system. Any person violating this provision shall be subject to immediate arrest under the charge of disorderly conduct.

#### **APPLICATIONS AVAILABLE IN THE VILLAGE CLERK'S OFFICE**

The Village Clerk's Office administers many applications for the Village Board. Applications that you can procure through the Village Clerk's Office are as follows:

<u>Park Applications</u> – This is to reserve the park for private parties, family reunions, ball games, etc. There are park applications in the clerk's office-\$50 deposit per day.

<u>Building Permits</u> – This is for any new buildings and remodeling done over \$2000 in value. Roofing does not require a building permit if the structure of the roof is unchanged. These permits are \$25.00 for the permit and \$1.00 for each \$10,000 worth of work for residential and \$50.00 for permit and \$5.00 for each \$10,000 worth of work for commercial.

<u>CDBG Loan Application</u> – Come into the Clerk's Office for more information and an application for a NO Interest Loan for remodeling of your home.

<u>Voter Registration</u> - This application is required for all new electors who move into the Village or have changed their name or their address since the last election. A change in residency form will be sent to the former municipality.

<u>Absentee Ballot Requests</u> – This would be requested if an elector was unable to come to the Municipal Building on Election Day but still wanted to vote.
